

## 6 County Minutes

May 13, 2013

Meeting called to order at 7:05 by President David Vane

Charles F made motion to approve March minutes. Bobbi seconded.

April balance 57621.77. Motion made to approve treasurer's report by Bobbi, seconded by Don. Motion passed.

VP - Lifeguard – Jim spoke with Curtis about dates he could work. He can work the first 3 weeks of camp, then 2 weeks off and then finish off the summer. What Jim would like to do is hire all 3 and give each 3 weeks, then have the balance of the two on call. Seconds are willing to live in the bunk area.

Workdays – Kerri workday very productive. All the boards in sleeping area of girls bunk done. Need to finish boards in boys bunks. Rex will have all the boards ready to go for whoever goes up next. Trees at pool area if we could clear hillside between road and pool house, it would dissipated and we might not have as big an issue. Lines in camp should be insulated and PGe should do for nothing. Kerri will email his proposal to us when she gets it.

PGe -- Scott talked to PGe, has sent application for CARE program. Bobbi got app, Scott will fill out for us. Copy of 501C and letter of intent. Could reduce our bill by a couple thousand. So we will give it a try.

New Business:

Charles brought proposal from Cut Right Tree Service to take tree over dining area, removing tree that hangs over road, etc. See proposal.

Tammy made a motion to accept Charles Cut Right Tree service proposal, up to 4000.00 to fix trees at camp. Second motion Charles Hampton. Approved.

Don suggested we get 1 key for the cupboards and try to get rid of the rest.

Bobbi said first aid kit in kitchen needs filled, especially needs burn gel.

Inspection went well we got an A in kitchen. Hood is supposed to extend over oven . Floor mats need to be cleaned in slop sink behind bathroom. Hot water at the pool and rat proof the pool house.

Water to be done by specific people Charles F or David Vane. We passed springs and all others.
